6. ACCIDENTAL RELEASE MEASURES

Personal precautions

7. HANDLING AND STORAGE

Handling

: Keep container tightly closed.

Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this preparation.

Storage
