## 4. FIRST AID MEASURES

### First-aid measures

- General** : In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person. If unconscious, place in recovery position and seek medical advice.
- Inhalation** : Remove to fresh air. Keep person warm and at rest. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel.
- Skin contact** : Remove contaminated clothing and shoes. Wash skin thoroughly with soap and water or use recognised skin cleanser. Do not use solvents or thinners.
- Eye contact** : Check for and remove any contact lenses. Immediately flush eyes with running water for at least 15 minutes, keeping eyelids open.
- Ingestion** : If swallowed, seek medical advice immediately and show the container or label. Keep person warm and at rest. Do not induce vomiting.

## 5. FIRE-FIGHTING MEASURES

- Extinguishing media** : Recommended: alcohol-resistant foam, CO<sub>2</sub>, powders.
- Extinguishing media not to be used** : Do not use water jet.
- Special exposure hazards** : Fire will produce dense black smoke. Exposure to decomposition products may cause a health hazard. Appropriate breathing apparatus may be required. Cool closed containers exposed to fire with water. Do not release runoff from fire to drains or watercourses.

## 6. ACCIDENTAL RELEASE MEASURES

- Personal precautions** : Exclude sources of ignition and ventilate the area. Avoid breathing vapour or mist. Refer to protective measures listed in sections 7 and 8. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations (see section 13).
- Environmental precautions** : Do not allow to enter drains or watercourses. If the product contaminates lakes, rivers, or sewers, inform the appropriate authorities in accordance with local regulations.
- Methods for cleaning up** : Preferably clean with a detergent. Avoid using solvents.

## 7. HANDLING AND STORAGE

- Handling** : Keep container tightly closed.
- Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this preparation.
- Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.
- Put on appropriate personal protective equipment (see section 8).
- Never use pressure to empty. Container is not a pressure vessel. Always keep in containers made from the same material as the original one.
- Comply with the health and safety at work laws.
- When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.
- Storage** : Store in accordance with local regulations. Observe label precautions. Store in a dry, cool and well-ventilated area. Keep away from heat and direct sunlight. Keep away from sources of ignition. Keep away from: oxidising agents, strong alkalis, strong acids. No smoking. Prevent unauthorised access. Containers that have been opened must be carefully resealed and kept upright to prevent leakage.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

<b>Respiratory system</b>	: If workers are exposed to concentrations above the exposure limit, they must use appropriate, certified respirators.  Dry sanding, flame cutting and/or welding of the dry paint film will give rise to dust and/or hazardous fumes. Wet sanding/flatting should be used wherever possible. If exposure cannot be avoided by the provision of local exhaust ventilation, suitable respiratory protective equipment should be used.
<b>Skin and body</b>	: Personnel should wear antistatic clothing made of natural fibres or of high-temperature-resistant synthetic fibres.
<b>Hands</b>	Not available.  Barrier creams may help to protect the exposed areas of the skin but should not be applied once exposure has occurred.

There is no data available on the preparation itself. The preparation is not classified as dangerous according to Directive 1999/45/EC and its amendments.

Exposure to component solvent vapour concentrations in excess of the stated occupational exposure limit may result in adverse health effects such as mucous membrane and respiratory system irritation and adverse effects on the kidneys, liver and central nervous system. Symptoms and signs include headache, dizziness, fatigue, muscular weakness, drowsiness and, in extreme cases, loss of consciousness.

Solvents may cause some of the above effects by absorption through the skin. Repeated or prolonged contact with the preparation may cause removal of natural fat from the skin, resulting in non-allergic contact dermatitis and absorption through the skin.
