4. FIRST AID MEASURES

First-aid measures

General: In all cases of doubt, or when symptoms persist, seek medical attention. Never give

Inhalation : Remove to fresh air. Keep person warm and at rest. If not breathing is

irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by

trained personnel.

Skin contact: Remove contaminated clothing and shoes. Wash skin thoroughly with soap and

water or use recognised skin cleanser. Do not use solvents or thinners.

Eye contact: Check for and remove any contact lenses. Immediately flush eyes with running water

for at least 15 minutes, keeping eyelids open.

Ingestion: If swallowed, seek medical advice immediately and show the container or label.

Keep person warm and at rest. Do not induce vomiting.

5. FIRE-FIGHTING MEASURES

Extinguishing media

: Recommended: alcohol-resistant foam, CO₂, powders.

Extinguishing media not to be used

Special exposure hazards

: Fire will produce dense black smoke. Exposure to decomposition products may

6. ACCIDENTAL RELEASE MEASURES

Personal precautions

: Exclude sources of ignition and ventilate the area. Avoid breathing vapour or mist. Refer to protective measures listed in sections 7 and 8. Contain and collect spillage with non-combustible, absorbent material e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations

(see section 13).

Environmental precautions

: Do not allow to enter drains or watercourses. If the product contaminates lakes, rivers, or sewers, inform the appropriate authorities in accordance with local

regulations.

Methods for cleaning up

: Preferably clean with a detergent. Avoid using solvents.

7. HANDLING AND STORAGE

Handling

: Vapours are heavier than air and may spread along floors. Vapours may form explosive mixtures with air. Prevent the creation of flammable or explosive concentrations of vapours in air and avoid vapour concentrations higher than the occupational exposure limits.

In addition, the product should only be used in areas from which all naked lights and other sources of ignition have been excluded. Electrical equipment should be protected to the appropriate standard.

To dissipate static electricity during transfer, earth drum and connect to receiving container with bonding strap. Operators should wear antistatic footwear and clothing and floors should be of the conducting type.

Keep away from heat, sparks and flame. No sparking tools should be used.

Keep container tightly closed.

Avoid contact with skin and eyes. Avoid the inhalation of dust, particulates, spray or mist arising from the application of this preparation. Avoid inhalation of dust from sanding.

7. HANDLING AND STORAGE

Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.

Put on appropriate personal protective equipment (see section 8).

Never use pressure to empty. Container is not a pressure vessel. Always keep in containers made from the same material as the original one.

Comply with the health and safety at work laws.

When operators, whether spraying or not, have to work inside the spray booth, ventilation is unlikely to be sufficient to control particulates and solvent vapour in all cases. In such circumstances they should wear a compressed air-fed respirator during the spraying process and until such time as the particulates and solvent vapour concentration has fallen below the exposure limits.

Storage

: Store in accordance with local regulations. Observe label precautions. Store in a dry, cool and well-ventilated area. Keep away from heat and direct sunlight. Keep away from sources of ignition. Keep away from: oxidising agents, strong alkalis, strong acids.

No smoking. Prevent unauthorised access. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not empty into drains.
